I am writing to you in order to respond to the NOTE presented on 05/06/2025, in a preliminary manner. I DENY each and every one of the facts and assertions contained in the presentation; furthermore, I DENY that the studies conducted by the aforementioned professionals have yielded a finding of "contamination" in either vaccines or any type of inocula. I DENY that the province of San Luis is experiencing an unusual increase in turbo cancers among young people, myocarditis, strokes, herpes zoster, allergies, or persistent congestion. I DENY that independent scientists from Argentina and San Luis are free from conflicts of interest. I DENY that studies and observations indicate that the inocula contain elements that should never be present in an injectable. I DENY the false, arbitrary, and intimidating assertion that the population is being poisoned. Therefore, I HEREBY NOTIFY: That ANMAT (Administración Nacional de Medicamentos, Alimentos y Tecnología Médica - National Administration of Medicines, Food and Medical Technology) is responsible for controlling and supervising the health and quality of drugs, chemical products, reagents, pharmaceutical forms, medicines, diagnostic elements, biomedical materials and technology, and any other product for use and application in human medicine. Likewise, it is responsible for protecting the population of the entire Argentine Nation by ensuring that health products are effective, safe, and of high quality. The Province of San Luis adheres to the Drug Traceability System of the National Administration of Medicines, Food and Medical Technology (ANMAT), formalized through Decree N° 634-MdeS-2012, as established by ANMAT Provision N° 3683/11. Therefore, the entire Province of San Luis is protected by this national traceability system and cannot, prima facie, deviate from or contravene this regulatory framework. Consequently, all medications are authorized for their correct use. Therefore, your petitions are inadmissible, ineffective, and lack factual, scientific, and legal basis. We assert, as a SCIENTIFIC and corroborated FACT, that vaccines represent one of the most significant advances in the field of medicine, playing a crucial role in the prevention of infectious diseases and the eradication of smallpox, the first human disease eliminated through a global vaccination effort. Other diseases, such as poliomyelitis, have been nearly eradicated, while the incidence of diseases such as measles, rubella, and diphtheria has decreased drastically. The positive impact of vaccines includes individual and collective protection, and the prevention of outbreaks. Benefits also include a reduction of the economic burden and improved quality of life. In light of the denial of these facts and legal basis, supported by objective and scientific foundations, we DEMAND: Cease the defamation and/or discrediting of the Provincial Ministry of Health and/or its officials in the exercise of their duties, under penalty of corresponding criminal and/or civil legal action. PLEASE PROCEED THROUGH THE APPROPRIATE PROCEDURAL CHANNEL. We hereby conclude this epistolary communication. YOU ARE HEREBY DULY NOTIFIED.
