<u>COMPLAINT</u>

Mr. Prosecutor:

Victor Eduardo Vital, National Identity Document 16.041.186, Carpenter, Retired, Malvinas War Veteran, acting on my own behalf, 6.923.064, residing at Barrio Matías Mercado, Block B, House 21, City of San Luis, with legal representation by Dr. Martín A. Villegas, attorney, establishing legal address at San Martín 865, City of San Luis, and electronic address at martinvillegas@giajsanluis.gov.ar, in the matter entitled: "VITAL VICTOR EDUARDO re: POISONING art. **200** <u>C.P. "I respectfully appear before y</u>ou and state:

OBJECT:

I hereby bring to your authority's attention facts that give rise to an ex officio public action, which came to light in the town of Potrero de los Funes on March 14th and 15th, and which demonstrate the commission of extremely serious crimes typified in the Penal Code as Poisoning with Medicinal Substances (art. 200

Penal Code), Commercialization, supply, and distribution of said substances (art. 201 of the Penal Code), and according to the evidence presented, the derivation to the crime of Abuse of Authority and Breach of the duties of a public official (art. 248 Penal Code), insofar as the warnings regarding the poisoning that my party has been making to the officials of the provincial public health services, render the action of commission by omission inexcusable, precluding any claim of ignorance or unawareness; all this, among other criminal offenses that Your Honor will know how to subsume at the opportune procedural moment, iura novit curia.

PRELIMINARY WARNING

Cognitive Dissonance: denial of evidence.

We hereby inform Your Honor that the description of the facts and

their evidence, following reliable confirmation obtained since March 14 and 15, 2 025, during the Congress held in Potrero de los Funes, may generate what is known as **Cognitive Dissonance** in any sensitive human being, honest citizen, and person of goodwill,

that being the automatic impulse to disbelieve what is being read or heard, because it contradicts the belief system that constitutes that human psyche. Therefore, with all due respect, Your Honor, we submit that the course of this process may generate emotionality and contradictions typical of a healthy conscience, given the inconceivable nature of the situation.

We say this also from our own experience, as the mere description of the facts has affected most of the medical professionals we contacted during this time, to the point of refusing to look through a microscope or to chemically analyze the contents of the injectables being analyzed worldwide, particularly in our country and recently in San Luis. This is only conceivable as the planning and execution of a sinister plan designed to sicken and kill people.

INTRODUCTION.

Once the so-called pandemic was declared, the so-called COVID -19 vaccines, along with influenza vaccines, began to be injected into family members, friends, and neighbors. Simultaneously, these inocula were being injected worldwide, throughout the country, fueled by the panic generated by the mass media, leading people to eagerly receive the injection "that would save them."

Shortly after the administration of these injections, purported to provide immunity to vaccinated individuals, we observed the emergence of rare diseases in young people and sudden deaths in athletes, occurrences previously unseen and, coincidentally, suppressed by the mass media. We began to receive alternative information primarily through the Telegram and Odysee platforms, as all platforms aligned with the official narrative censored any information that questioned the prevailing narrative of virus – contagion – the necessity of vaccines as the sole solution, etc. (YouTube , Facebook, and Instagram engaged and continue to engage in the brutal censorship described).

Scientists from abroad discovered an alternative source of information in the journalistic channel La Quinta Columna, led by the Spanish physician José Luis Sevillano and biostatistician Ricardo Delgado, who pioneered the channeling of independent investigations into the true content of the vaccines and their effects, e.g., microscopic analyses of vaccines conducted by Dr. Pablo Campra Madrid of the University of Almería, Spain.

The Campra report triggered a series of varied and comprehensive investigations and analyses regarding the contents of the vials of the socalled COVID-19 vaccines; therefore, today we know the truth of what happened.

That truth constitutes a blatant scam against legitimate science and against doctors and scientists of good faith who believed in an orchestrated scheme, the investigation of which, as it pertains to San Luis, will be the subject of this criminal process.

During this time, what was found in the analyzed vials of "COVID -19 vaccines," influenza vaccines, dengue vaccines, and, in general, vaccines from the schedule (administered to newborns, children, and adolescents), dental anesthetics, physiological saline solutions, etc., is graphene oxide and derivatives, along with more than 62 chemical elements not declared as part of any compound in the different formulas, and a high amount of particulate material of size nanometric and micrometric, which does not comply with the Argentine Pharmacopoeia's requirements for injectables (chapter 650), the self-assembly of these particles in vitro and their interaction with the radiation waves emitted by 5G antennas having already been evidenced. Consequently, it is sufficient for a vaccinated person to approach an antenna and/or for the power of antennas to be increased in areas where vaccinated people live, for the graphene oxide to interact with the radio frequencies and cause what is known as the "COVID-19" symptom, cytokine storm, shortness of breath, gastroenteritis, myocarditis, sudden deaths, etc.

Subsequently, in our country, CONICET scientists Dr. Marcela Sangorrín and Lic. Lorena Diblasi conducted separate analyses of vials. Their conclusions are offered as expert evidence in this document. Informative statements from these scientists, summarizing their conclusions, are copied here:

Your Honor should note the shock that we experienced, and continue to experience, upon learning that an injection, vial, anesthetic, serum, vaccine, etc., whose stated purpose is to "cure," "heal," or "prevent," contains undeclared nanoparticles that should not be present under any circumstances, and that such a substance should never be introduced into the body of any living being, whether human or animal

While we were sharing scientific information on Telegram and Odysee—information that was totally and absolutely censored by the major internet platforms and suppressed by the mass media (Cognitive Dissonance and/or complicity)—we initiated contact with a minority of doctors and scientists who began to group together in networks, Zoom meetings, and in-person gatherings. This was in order to consolidate, at a Scientific Congress, the information available at that time showing that the contents of the vials, inocula, or vaccines were completely contaminated with graphene oxide, nanomaterials, and/or nanotechnology , with the purpose of causing illness, depressing the immune system, generating COVID symptoms, and slowly killing.

This is how we managed to organize and carry out a scientific Congress in the town of Potrero de los Funes on March 14 and 15, 2025. We attach the flyer for illustrative purposes, which is entitled: *"First Congress on Deliberate Damage caused by Vaccines, Electromagnetic Radiation, and Toxic Atmospheric Fumigation*." At the congress, we analyzed influenza vaccines, dengue fever vaccines, and physiological saline solutions, all acquired at a pharmacy in San Luis. This provides the first element of the territorial jurisdiction of V.S.: the place of the event, the place of commission, and the effect of the poisoning on people domiciled in San Luis.

The analysis of the vials was carried out by the CONICET scientists, including Dr. Marcela, who were specially invited to the Congress. Sangorrín and Lic. Lorena Diblasi, along with Doctors Liliana Gabriela Zelada and Martín Monteverde, having prepared dark-field optical microscopes, filming, and photos with the safeguard of public faith in the actions of Notary Public Dr. Juan Cruz Bertín.

Attached to this complaint are Notarial Act No. 33 of March 14 , 2025, and Notarial Act No. 35 of March 15, 2025, the content of which, certified by the scientific experts who performed the microscope analysis, constitutes full proof of the intentional act of poisoning carried out with the analyzed injectables. We state that the acting Notary Public has in his possession the vials and physiological saline solution analyzed, held under his custody so that they may be requested by the court.

We also believe that we are facing a consummated state of continuing offense, for which V.S. can assuredly order the seizure of new vials and serums in any pharmacy in San Luis, or the COVID vaccines held by the Ministry of Health, which monopolizes COVID vaccines and routine immunizations; and, with the necessary custody, ethical considerations, and considering the latent conflict of interest of some scientists, order their comparison and analysis to determine the extent of the actions we are reporting.

Therefore, I request the following from V.S.:

1.- Accept this presentation of myself, acknowledge the declared addresses, and recognize this filing of a public criminal complaint ex officio, for the commission of the crimes of poisoning with medicinal substances and the distribution thereof, in actual concurrence with other penal classifications defined in Articles 200, 201, 248, and 45 of the Argentine Penal Code.

2.- The initial evidence is offered, including inductive expert scientific information , notarial public deeds, and statements from the doctors and

scientists participating in the Congress in Potrero de los Funes, who are willing to testify in an informative, testimonial, and/or expert capacity if V.S. deems it pertinent. This evidence is hereby offered.-

3.- At the time of presenting this complaint, Mr. Luis Alberto Balocco, DNI 13 .255.035, residing at Abelardo Figueroa 568, City of San Luis, appeared at the Law Firm. He is one of the many people injured by the COVID vaccines, and in light of the description of the facts and their evident causal relationship, his integrity and physical safety being affected, his case falls under Article 91 of the Penal Code: Very Serious Injuries. We attach a description of the facts and documentation of his case. Given the clear connection of cause, uniformity of evidence, and the vaccines as a poisonous element and the cause of the injuries, it is pertinent that the present case be processed as one unified case, which we hereby request, considering that a criminal complaint has also been filed for the crime of very serious injuries –art. 91 C.P.– to the detriment of citizen Luis Alberto Balocco due to the administration of the vaccines containing a poison. or explicit.-

4.- For all the foregoing, we respectfully request that Your Honor schedule a hearing for the formal ratification of this complaint by citizens Victor Eduardo Vital and Luis Alberto Balocco.-

Provide accordingly. It will be Justice.
